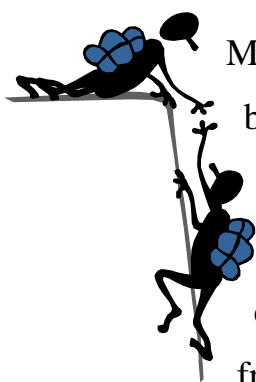

- ◆ **Will I lose my Medicaid and Medicare if I work?**

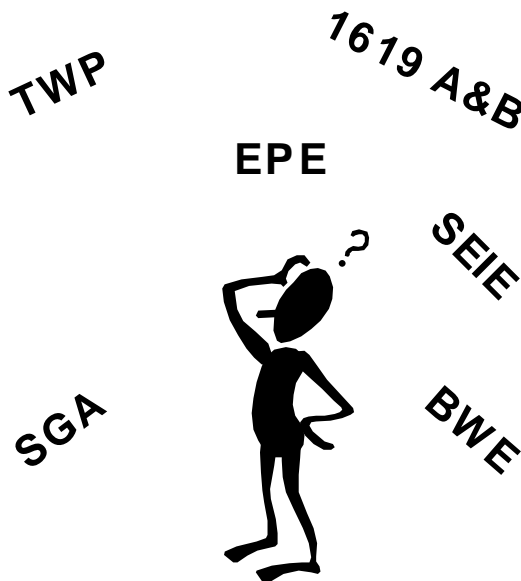
BENEFITS PLANNING AND ASSISTANCE



Many people mistakenly believe that they cannot work because they are receiving disability benefits from the Social

Security Administration. In fact, Social Security encourages people receiving benefits to try work through the provisions of work incentives. Information about these work incentives allows an individual to determine if they can improve their quality of life without irrevocably sacrificing all of their benefits.

HELP IS AVAILABLE

The Office of Rehabilitation Services (ORS) recently received a grant from the Social Security Administration to insure that Rhode Islanders who receive SSI and/or SSDI on the basis of disability understand their benefits and how work affects those benefits. As part of this grant, ORS has contracted with the Ocean State Center for Independent Living (OSCIL) to provide benefits planning, assistance and outreach services.
